## THE VOICE FOR PUBLIC CHARTER SCHOOLS AT THE STATE CAPITOL

TCSC's government affairs team leads the fight for public charter schools in Tennessee. Lobbyists can cost thousands of dollars monthly, but membership means access to a powerful team fighting for your best interests at a low cost.

- Every year, policies are proposed to negatively impact TN's non-profit charter sector and limit charter school autonomy, growth, and access to resources:
  - o For-profit charter schools in your town
  - Increased paperwork and bureaucracy for your schools
  - Caps on charter growth and enrollment

TCSC is focused on fighting anti-charter policies and has a 100% defeat rate over more than five years.

- TCSC's team pushes the agenda to ensure one of the strongest environments for high-quality public charter schools in the country by fiercely advocating for key policy victories:
  - Establishing a charter schools facility fund that has allocated \$74 million to your public charter school facilities to date
  - Removing the cap on the number of public charter schools allowed in TN
  - Establishing an appellate authorizer, first through the State Board of Education and now the TN Public Charter School Commission, ensuring applications receive a fair evaluation independent of politics
  - Advocating to ensure the unique needs of public charter schools are considered in major education policies like the redesign of the BEP formula and changes to State standards
  - Major education policies like the development of the TISA funding formula and changes to the state's accountability framework
